# On Issues of writ petition, interim order and To identify possible strategy for future and role of the Local Government

#### **Agendas:**

#### **Briefing of the Meeting:**

The People Forum facilitated the webinar with an objective to discuss on issues of writ petition, interim order and to identify possible strategy for future, where such type of discussion would assist MRC Staffs to work on Migrant workers issues in the Local Level. As this webinar was conducted with the motivation to acknowledge the legal context in regards to Migrant workers abroad during this pandemic. RERP Migration team responded to the webinar by inviting the MRC/MID staffs and other concerned officials of the Municipality from the 14 local levels of Province 1 and 2.

The webinar was moderated by Adv. Krishna Neupane, facilitated by Adv. Shom Luintel, technically supported by Adv. Sudip Devkota and coordinated by RERP Migration Team. The webinar was addressed in lecture format by the facilitator. Later the floor was handover to the Municipality officials for further discussion. The webinar concluded with a question and answer from various respondents.

#### **Discussions:**

Adv. Shom Luintel highlighted that COVID-19 has been impacting migrant workers as they have been facing different problems in the destination countries. Problems include discrimination in treatment, inadequate quarantine facility, non-payment of salary, wage cut, layoff, job loss and being stranded. In this context the advocates associated with People Forum for Human Rights (People Forum) have filed Public Interest Litigation (PIL) in response to the massive spread of Covid-19 in destination countries. Now Supreme Court has issued an interim order to the government, which has initiated a debate at the political, migrant community, citizen and parliamentary level on how and when we can rescue, repatriate and reintegrate the stranded migrant workers abroad following the World Health Organization Standards.Adv. Luintel well-versed

about the COVID-19 response taken by the Nepalese Government for the migrant workers abroad through the concerned Department under Ministry of Labour, Employment and Social Security and Ministry of Foreign Affairs through the embassies and consular's.

The section 11(q) of the Local Government Operation Act, 2074 has set an obligation of integrating migrant workers with the local government. The federal government shall enhance coordination between the Foreign Employment Board (FEB) and local government for an effective reintegration programme. FEB shall establish the policy, procedure and programme, and the local government should implement such a programme. The local government should initiate data collection of migrant workers and returnees to effectuate the reintegration program in norms to the Local Government Authorization Directives. He updated on actions taken by other labour exporting countries in this emergency. He further suggested on how the Foreign Employment Welfare Fund could be mobilized at this time period and the use of skill certification categories to reintegrate the returnee migrant in the national economy.

Further, the officials from the 14 local levels informed about the preparation and planning done at their local level in order to reintegrate the returnee migrants. Some local levels had identified to centralize in agriculture whereas some were planning to mobilize on the basis of the skills that returnee migrant workers have. The Chief Administration Officer of Kohlabi was hopeful about the further support and guidance from the Migration Information Desk in reintegrating returnee migrants. Few MRC/MID staffs also asked questions regarding legal remedy that would come along counseling and case handling process.

#### **Outputs:**

- MRC/MIDs and Local level officials were acknowledged about the legal action taken in response to COVID-19 pandemic.
- Local Level officials were directed with possible solutions for reintegration of returnee migrants at local level.
- The MRC/MIDs would be further consulting with the People Forum for further legal remedies.
