2. Rural Enterprises and Remittances Project (RERP) "SAMRIDDHI", Project Management Office (PMO) invites sealed bids under the following Terms and Conditions from the interested and eligible bidders.

The interested bidder may purchase bidding document upon submission of written application along with copies of company/firm registration certificate, manufacturers/Authorized dealer's authorization letter for the respective goods and services, Tax registration Certificate (PAN/VAT) & Tax clearance of FY 2073/74 and a cash payment (non-refundable) as mentioned below from the office of RERP "SAMRIDDHI", PMO, Itahari-20, Sunsari during office hour.

5. Bids must be valid for a period of 90 days after the bid closing deadline. Bids must be accompanied by a Bid Security in the amount as mentioned in the above table either in the form of Bank Voucher in the name of Ko. Le. Ne. Ka Dharauti Khata No. 22-20-20-3000000 (Rastrya Banijya Bank, Inaruwa) or irrevocable and unconditional Bank Guarantee issued by "A" class commercial bank with a minimum amount as indicated in the above table. The bid security shall be valid for 30 days beyond the validity period of the bid.
6. Sealed bid must be delivered by hand or courier on or before 17<sup>th</sup> magh 2074 (31<sup>st</sup> January, 2018) on or before 12:00 (noon) at office of RERP "SAMRIDDHI", Itahari-20, Sunsari. Bids received after this deadline will be rejected.

Bids will be opened at 12:30 PM on 17<sup>th</sup> magh 2074 (31<sup>st</sup> January, 2018) in the presence of bidders or their authorized representatives who wish to attend at office of RERP "SAMRIDDHI", Itahari-20, Sunsari. Absence of bidder's representative in bid opening shall not obstruct the bid opening.
8. If the last date of the Bid purchasing, submission and opening falls on a public holiday, the next working day shall be considered as the last date. In such case the bid validity and bid security validity shall remain the same as specified for the original last date of bid submission.
